

# PENNSYLVANIA TURNPIKE COMMISSION

## RETENTION OF AN ENGINEERING FIRM

Full Depth Roadway Reconstruction Milepost T57 to T67  
Allegheny and Westmoreland Counties

### Reference No. 1-155

The Pennsylvania Turnpike Commission will retain an engineering firm to perform preliminary and final design services for the full depth roadway reconstruction project from Milepost T57 to T67 (from Pittsburgh Interchange to Irwin Interchange) in Monroeville Borough, and Penn and North Huntingdon Townships, Allegheny and Westmoreland Counties. This project will include the reconstruction of approximately 10.5 miles of the Turnpike and will result in a six-lane typical section and widening of the median width from ten (10) feet to twenty-six (26) feet. The reconfiguration of the Irwin Interchange ramps, from the mainline to the toll plaza, is also included with this project. The ramps at Pittsburgh Interchange are not included in this project. Also included is the replacement of all overhead and mainline structures, the lengthening of culverts, the acquisition of Right-of-Way, and the possibility of retaining and/or noise walls.

The engineering services required will include supplemental field surveys, cross sections, evaluation of utility conflicts and potential relocations, development of erosion and sedimentation control plans and narrative, preparation of hydraulic reports for waterway approvals, preliminary and final traffic control plans, structural foundation reports, preparation of Type Size and Location and final bridge plans, preparation of preliminary and final right-of-way plans, geotechnical investigations, environmental studies and permitting, stormwater management, preparation of preliminary and final construction plans and specifications. Public Relations with the adjacent communities will also be part of this project. Right-of-Way acquisition services will also be part of this contract.

Low-level photography will be available for the project that meets NMAS for photo scale 1"=200'. DTM files in AutoCAD DWG and Microstation DGN format will also be provided. The Consultant will be required to perform supplemental surveys and reestablish the existing centerline of the Turnpike. Also, cross sections will be cut and plotted from the available information. The design for this project will be performed in English Units. All plans (drawings), including cross-sections, profiles, etc. will be prepared utilizing AutoCAD DWG or Microstation DGN format. Translation of the plans from one format to the other is not acceptable.

**The following factors are listed in order of importance and will be considered by the Commission during the evaluation of the firms submitting a Statement of Interest for this project:**

- a. Firm's experience working on major roadway and bridge reconstruction projects and including stormwater design, noise analysis and mitigation, and environmental permitting. The firm should identify similar projects that have been completed as well as the magnitude and client.
- b. Provide discussion on the firm's understanding of the anticipated project specific issues and challenges.
- c. Project Manager's experience and the experience of the key staff with similar projects and how they will manage their design team including any subconsultants to ensure quality

project submissions that meet all established submission dates.

- d. Provide discussion on the proposed team's QA/QC program and how the prime consultant will ensure the accuracy and completeness of all deliverables.
- e. Workload of the prime consultant and subconsultants for all Pennsylvania Turnpike Commission and Department of Transportation projects. Any other factors or insights specific to the project.

Address these items and any necessary further details in a brief yet comprehensive manner in the Statement of Interest.

## **GENERAL REQUIREMENTS AND INFORMATION**

Firms interested in providing the above work and services are invited to submit a Statement of Interest with the required information. The Statements of Interest must include the following:

1. One page transmittal letter clearly identifying the project reference number, brief description of the project from the advertisement, the firm's federal identification number, the firm's legal name, contact person or project manager, address of corporate office and project office. (If the firm has multiple offices, the location of the office performing the work must be identified). In addition, identify the CADD format to be used on the project.
2. A five (5)-page statement of interest on the advertised project. Each firm should demonstrate their ability to perform the specific requirements indicated for each project and provide explanation of the technical approach including the roles of each subconsultant and the extent that each subconsultant will be utilized.
3. An organization chart for the Project, identifying key personnel and identifying all subconsultants and their specific assignments. Any deviation from the subconsultant's listed in the statement of interest will require written approval from the Commission.
4. Tabulation or listing of workload for the prime consultant and all subconsultants for all Pennsylvania Department of Transportation and Pennsylvania Turnpike Commission projects. Do not graphically represent the firm's workload.
5. A Consultant Qualification Package similar to the one submitted to the Pennsylvania Department of Transportation for the current year or one that is best suited for this project. A copy of the Consultant Qualification Package printed directly from PaDOT's ECMS website is acceptable.

The Consultant Qualification Package should contain, at a minimum, the following information for the prime consultant and all subconsultants and attached to the back of the Statement of Interest (subs to follow primes):

- ECMS General Information and Project Experience Forms or Standard Form (SF) 254 or 330 - Architect-Engineer and Related Services Questionnaire in its entirety, either not more than one (1) year old as of the date of the advertisement.
- Resumes of key personnel expected to be involved in the project. (Limit to two (2) 8 1/2 x 11 pages, per person). Only resumes of key personnel should be included.
- Copy of the firm's registration to do business in the Commonwealth as provided by the Department of State for firms with out-of-state headquarters or corporations not incorporated in Pennsylvania.
- A copy of the firm's DBE/MBE/WBE Certification, if applicable.

If a Joint Venture responds to a project advertisement, the Commission will not accept separate statements of interest from joint venture constituents. A firm will not be permitted to submit a Statement of Interest on more than one (1) joint venture for the same project reference number. Also, a firm that responds to a project as a prime may not be included as a designated subconsultant to another firm that responds to the same project advertisement. Multiple responses under any of the foregoing situations will cause the rejection of all responses of the firm or firms involved. This does not preclude a firm from being set forth as a designated subconsultant to more than one prime consultant responding to the project advertisement.

The Turnpike Commission is committed to the inclusion of disadvantaged, minority, and woman firms in contracting opportunities. The minimum participation level for DBE/MBE/WBEs in this contract will be 10%. Responding firms shall clearly identify in the Statement of Interest the DBE/MBE/WBE firms expected to participate in this contract and shall indicate the intent to maintain the minimum participation level throughout the life of the contract. Proposed DBE/MBE/WBE firms must be certified by the Pennsylvania Department of General Services ([www.dgs.state.pa.us](http://www.dgs.state.pa.us)) or the Pennsylvania Unified Certification Program ([www.paucp.com](http://www.paucp.com)) at the time of the submission of the Statement of Interest.

The Statement of Interest and required information must be received by 12:00 PM (noon), Local Time, **Thursday, July 14, 2011**. Any Statements of Interest received after this date and time will be time-stamped and returned.

Based on an evaluation of acceptable Statements of Interest received in response to this solicitation, the Commission will select one (1) firm for the purpose of negotiating an agreement. Technical Proposals will not be requested before the selection.

The Commission may revise a published advertisement. If the Commission revises a published advertisement less than ten days before the Statement of Interest due date, the due date will be extended to maintain the minimum ten-day advertisement duration if the revision alters the project scope or selection criteria. Firms are responsible to monitor advertisements to assure the Statement of Interest complies with any changes in the published advertisement.

The Commission reserves the right to reject all statements of interest, to cancel solicitation requested under this notice, and/or to re-advertise solicitation for the work and services.
