The Commission has selected STV Incorporated for award based on the Commission's determination that the firm's Statement of Interest is the most advantageous to the Commission as determined by the Commission based on its review of all materials submitted. The firm has significant CM/CI experience on large projects including a recent complex construction project for the PTC. Its key staff and team demonstrated significant experience and capabilities

- b. T00167, construction inspection services for the roadway and bridge reconstruction from MP 324.00 to MP 326.00:
  - TRC Engineers, Inc.-AWARDED
  - AECOM Technical Services, Inc.
  - Stantec Consulting Services, Inc.

-was made by Commissioner Wozniak, seconded by Commissioner Ahmad, and passed unanimously. The Commission has selected TRC Engineers, Inc., for award based on the Commission's determination that the firm's Statement of Interest is the most advantageous to the Commission as determined by the Commission based on its review of all materials submitted. The

firm has significant construction services experience, highly qualified key staff members and has the lowest current workload with the PTC of the 3 highly recommended firms.



## ITEM ADDED TO THE FORMAL AGENDA

Motion-That the Commission approves the negotiation and execution of an agreement with Waze to support customer and employee safety in PTC work zones with geo-located, incident-based messaging and safety reminders on its mobile navigation app; at an approximate cost of \$50,000.00-was made by Commissioner Wozniak, seconded by Commissioner Ahmad, and passed unanimously.



## **POST-FORMAL MEETING**

Charles Duncan III, Esquire, Chief Compliance, Legislative and Cultural Affairs, and staff members on the Social and Racial Justice task force presented their finding and recommendations to the Commission, staff and visitors on the call. Mark Compton thanked everyone who worked on the project and ensured the report will be provided to the Commissioners and will be followed up on.
