Brad Heigel, P.E., Chief Engineer presented information to the Commission on the Delaware River Bridge regarding the age of the bridge, the January – March 2017 emergency repairs that necessitated closing the bridge during the repair; an RFI issued via PennDOT in November of 2019, ongoing FEIS reevaluation, and project delivery discussions with NJTA.
