Acquisition of Right-of-Way #14S711 (United States Steel Corporation, successor in interest to Carnegie Steel Company); a partial take parcel necessary for construction of the Mon-Fayette Expressway, Rt. 51 to I-376, by authorizing payment of \$4,234.50 representing fair market value and pro-rated taxes to United States Steel Corporation; authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that may be required for closing; authorize payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of a deed as prepared by the Legal Department;
- d. Jaindl), a partial take parcel necessary for the bridge replacement project at MP A59.55 by authorizing payment of \$3,300.00 representing fair market value to David M. Jaindl; authorize the appropriate Commission officials to execute the Temporary Construction Easement and other documents that may be required for closing; authorize payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of the Temporary Construction Easement as prepared by the Legal Department;
- f. Acquisition of Right-of-Way #6168-A (Kathy Ramsey; Jacob Colletti), a total take parcel necessary for construction of the Lafayette Street Connector by authorizing payment of \$741,228.93 representing fair market value, pro-rated taxes and recording fees to Diversified Settlement Services, Inc., escrow agent; authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that may be required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owners is contingent upon the delivery of a deed as prepared by the Legal Department;
- g. Acquisition of Right-of-Way #14S040 (The Port Authority of Allegheny County), a partial take parcel necessary for construction of the Mon/Fayette Expressway, Rt. 51 to I-376, authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that may be required for closing; and authorize payment of Statutory 710 damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel;
- h. Settlement Agreement with Jay W. Lewis, Jr. and Nickole L. Smith Lewis, owners of property adjacent to the Southern Beltway limited access right-of-way; for the transfer of landlocked, surplus property to the Lewis; and authorize the appropriate Commission officials to execute the Settlement Agreement, Subdivision Plan, Deed and other documents that may be required for

closing; transfer of the surplus parcel is contingent upon the execution and delivery of a Full and Final Settlement Agreement and Release of Claims as drafted by the Legal Department.

Supplemental Agreement #1 with Gannett Fleming, Inc. for design services for the total reconstruction project from MP A53.00 to MP A57.00, for an increase of \$18,000,000.00 to complete final design of this complex total reconstruction project that includes the complete reconfiguration of the Lehigh Valley Interchange and toll plaza and the complete replacement of five (5) bridges that will require difficult construction staging; for a revised not-to-exceed amount of \$30,000,000.00;
- b. Supplemental Agreement #2 with ms consultants, inc. for design services for the total reconstruction project from MP 28.00 to MP 31.00, for an increase of \$3,000,000.00 to complete the reconfiguration design of the Warrendale Toll Plaza; for a revised not-to-exceed amount of \$14,500,000.00;
- c. Supplemental Agreement #4 with CDR Maguire, Inc. for construction management services for the Southern Beltway, Rt. 22 to I-79, for an increase of \$1,900,000.00 for additional construction management services for S.R. 0980 drainage piping and stream relocation work; Section 55C2-1 staffing beyond the timeframe that was originally anticipated; Section 55M staffing beyond the timeframe that was originally anticipated; Section 55C1-1 close-out efforts beyond what was originally anticipated; and additional PA DEP environmental permit close-out requirements; for a revised not-to-exceed amount of \$25,900,000.00.
