# **POLICY LETTERS**

Motion-That the Commission adopt revisions to a policy and adopt a new policy for the items listed in memos "a" and "b":

- a. Revisions to Policy 7.04, Procurement, to clarify the application of Contractor Integrity Provisions in contracts and procurement documents, simplify terminology, modify the approval process to issue RFPs, clarify obligations for maintaining confidentiality, and clarify the obligations for the disclosure of conflicts of interest in the procurement phase and during the performance of the contract;
- b. Adopt new Policy Letter 8.16, Acceptable Use Policy for Artificial Intelligence (AI) Including Generative AI (GenAI), to inform Pennsylvania Turnpike Commission Authorized Users of Commission technology resources of their responsibilities related to the acceptable use of AI Tools including GenAI, promote ethical and responsible use of AI Tools, and ensure data privacy and security regarding such activities.

# **AGREEMENTS**

Motion-That the Commission approve the negotiation and execution of the Agreements for the items listed in memos "a" through "c":

- a. Supplemental Reimbursement Agreement with East Penn Railroad for bridge repairs at structure DB-252 at MP H42.35 for an increase of \$125,000.00 due to unexpected additional necessary work that was not originally anticipated during the design; for a revised not-to-exceed amount of \$375,000.00;
- b. Supplemental Reimbursement Agreement with PECO Energy Company for the I-95 Interchange project that requires electric line relocation at MP 355.63, for an increase of \$379,533.79 due to higher costs from the time the estimate was provided to when actual work was performed; for a revised not-to-exceed amount of \$621,987.95;
- c. Interagency Agreement with the Pennsylvania Department of Transportation (PennDOT) for the Alternatives Analysis for the replacement of Commission-owned Bridge WB-305 and widening of SR 3022; PennDOT will reimburse the Commission for the approved costs associated with the development of the Alternatives Analysis.

## **SUPPLEMENTAL AGREEMENT**

Motion—That the Commission approve the negotiation and execution of Supplemental Agreement #2 for Contract #EN-00288-01 with Gibson Thomas Engineering for open-end design services, to continue the contract through the construction phase of the Access Ramps at MP 238.00 for support of the Engineering Digital Delivery Effort; for an increase of \$150,000.00; for a revised not-to-exceed amount of \$2,500,000.00-was made by Commissioner Deon, seconded by Commissioner Lieberman, and passed unanimously.

- b. Contract #T-319.00R002-3-02 for asphalt resurfacing between MP 319.33 and MP 322.22, to the lowest responsive and responsible bidder, Highway Materials, Inc.; at a not-to-exceed amount of \$4,772,277.00 and a contingency of \$235,000.00;
- c. Contract #A-053.00T001-3-05 for replacement of Bridge NB-336 at MP A53.36, to the lowest responsive and responsible bidder, Deblin, Inc.; at a not-to-exceed amount of \$17,638,622.28 and a contingency of \$1,100,000.00.
- was made by Commissioner Deon, seconded by Commissioner Lieberman, and passed unanimously.
