Personal E-ZPass Addendum- Fees and Charges

1. TRANSPONDER FEES

2. PREPAID OPENING BALANCE

The minimum amount required to open a POV Service is determined by the number transponders on the service at a rate of \$35 per transponder.

3. REPLENISHMENT AMOUNT

Your account balance must be replenished pursuant to one of the following procedures (as selected in your application):

- a. Automatic account replenishment by Credit Card or Automated Clearing House (ACH) payment. Whenever an account balance reaches a cumulative value of \$10 or less per hardcase E-ZPass transponder (\$10 x # of hardcase transponders), your Credit Card or bank account will be automatically charged a minimum of \$35 per hardcase E-ZPass transponder to replenish your account. If your account requires more than the allowed replenishments in a one-month cycle (2 times for credit cards and 3 times for ACH), the amount of replenishment must be increased based on average usage. If it is not increased, the account may be subject to additional charges.
- b. Manual account replenishments by Cash, Check or Credit Card. Whenever an account balance reaches a cumulative value of \$15 or less per hardcase E-ZPass transponder (\$15 x # of hardcase transponders), you must make a replenishment payment of at least \$35 per hardcase E-ZPass transponder by one of the following means:
 - i. Mailing a check to the E-ZPass Customer Service Center (CSC).
 - ii. Visiting the CSC to pay by cash or check.
 - iii. Authorizing an individual payment by Credit Card.

4. ADDITIONAL FEES

- a. **Lost/Stolen Fee-** A fee of \$10.00 is charged to an E-ZPass customer for each lost/stolen or damaged hardcase transponder.
- b. **Annual Fees-** POV services are subject to \$3.00 annual account fee. This fee is applied annually during the month the service was established.
- c. **Transponder Deposit Fees-** A \$10 transponder fee is charged to the customers' account when a customer returns a PTC issued hardcase transponder that is damaged, still under warranty and was not purchased.
- d. **Retailer Convenience Fee-** Retailers are permitted to charge customers who purchase GoPaks a convenience fee retained by the retailer. The maximum convenience fee is \$7 per GoPak.
- e. **Statement Fee-** Statements are available online for 18 months at no charge. Paper statements are available upon request and at a cost of \$4 for every 3 transponders.
- f. **Returned Check and Returned ACH transaction-** Should an overdraft occur, a fee not to exceed \$25 shall be applied to the account.
