Planned Construction Activities for the Week of July 27, 2026

SECTION 53A1

JEFFERSON HILLS BOROUGH, ALLEGHENY COUNTY

Contractor: Trumbull Corporation

1. Work Shift

- The standard work shift is 7:00 AM to 5:00 PM, Monday to Thursday. Friday and Saturday shifts will be used as needed.

2. Traffic

- **Coal Valley Road** – Coal Valley Road is open.
- **SR 885 Clairton Road** – There will be limited construction traffic in this area.
- **PTC 43/Jefferson Boulevard** – PTC 43 southbound drivers will be using the southbound ramp. Northbound drivers will cross over to the southbound side to Jefferson Boulevard. Traffic switches are anticipated in early August for crossover removal. All northbound traffic will return to northbound off ramp to Jefferson Boulevard.
- **Rt 51** – Follow traffic signs, arrows, merging areas, stop and yield signs. Lane closure on northbound and southbound during non-peak hours for sign installations.

3. Roadway and Bridge Work

- **Bridge 400/401 over Brickyard Rd/SR 51/Peters Creek** – Majority of work on both bridges is complete.
- **Existing Northbound Ramp Bridge 342 over Brickyard Rd/Rt 51** – Bridge closed for expansion dams replacement. Dams are installed and concrete in cure.
- **Toll Facility** – Toll facility building interior finishes. Electrical and communication work ongoing for toll facility. Final inspections.

4. Noise/Dust/Runoff Control

- Stormwater basins converted to receive water run off from roadways and slowly releases water into the natural waterways.

5. Trespassing on Construction Site

- The construction being performed in this area is a Limited Access Right-of-Way owned by the Pennsylvania Turnpike Commission. The construction areas are posted with No Trespassing/Private Property signs. **No pedestrians, ATVs or motorcycles should be entering the area.**
- Violators may be prosecuted under Section 3503(b)(1)(ii) which forbids criminal trespass.
