1. Work Shift


 The standard work shift is 6:00 AM to 4:30 PM, Monday to Thursday. Friday and Saturday shifts will be used as needed.

2. Traffic

- <u>Coal Valley Road</u> <u>Coal Valley Road is open.</u>
- <u>SR 885 Clairton Road</u> There will be construction traffic and truck deliveries in this area.
- PTC 43/Jefferson Boulevard PTC 43 southbound drivers will be using the southbound ramp. Northbound drivers will cross over to the southbound side to Jefferson Boulevard. Please monitor speed and stay in your lane through the construction area.
- <u>Jefferson Boulevard/SR 51</u> Follow traffic signs, arrows, merging areas, stop and yield signs.
- Pitt McKeesport Boulevard Utility relocation work is ongoing in this area for future projects.

3. Roadway and Bridge Work

- <u>Bridge 400/401 over Brickyard Rd/SR 51/Peters Creek</u> Majority of work on both bridges is completed.
- <u>Bridge 402 over Jefferson Boulevard</u> Majority of work is completed. Using as construction access across Jefferson Boulevard.
- Bridge 403 SR 885 over PTC 43 Majority of work is completed. Open to traffic with construction traffic under bridge.

Planned Construction Activities for the Week of November 17, 2025

- Bridge 404/405 over Coal Valley Overhang removal. General clean up.
- Long Life Concrete Paving Completing remaining slabs at shoulders and gore areas.
- **Toll Facility** Toll facility building interior finish HVAC and electrical work.
- **Jefferson Boulevard** Traffic is in a temporary configuration until the PTC 43 northbound off ramp is reopened. The Payne Hill Road entrance is open.

4. Noise/Dust/Runoff Control

- Erosion control measures are installed and will be modified as construction advances. The erosion controls will be maintained as necessary and removed when no longer needed.
- Permanent ditches take runoff water to storm water basins.
- Storm water basins hold water for slow dispersion. Pond conversion almost completed.

5. **Trespassing on Construction Site**

- The construction being performed in this area is a Limited Access Right-of-Way owned by the Pennsylvania Turnpike Commission. The construction areas are posted with No Trespassing/ Private Property signs. No pedestrians, ATVs or motorcycles should be entering the area.
- Violators may be prosecuted under Section 3503(b)(1)(ii) which forbids criminal trespass.
