
# RIGHT-OF-WAY AND CONSTRUCTION SCHEDULE Jefferson Hills to Duquesne

The materials at this Open House Plans Display will focus on the three design sections:


- ⇒ 53A: Clairton Boulevard (PA Route 51) to Camp Hollow Road, within the municipalities of Clairton, Jefferson Hills and West Mifflin
- ⇒ 53B: Camp Hollow Road to Homeville Road, within the municipalities of West Mifflin and Dravosburg, and
- ⇒ 53C: Homeville Road to Duquesne Boulevard (PA Route 837), within the municipalities of West Mifflin and Duquesne.

Each of those stations is designed to help you better understand plans for the expressway south of the Monongahela River (including engineering design, right-of-way acquisitions, noise impacts and the construction schedule).

#### **Station I: Project Overview**

A project overview map and overview of the project's schedule south of the Monongahela River (Jefferson Hills to Duquesne) are available at this station.

This is the largest station and provides a variety of maps for the southern section of the Mon/Fayette Expressway PA Route 51 to I-376 Project. Maps cover from Jefferson Hills to Duquesne (affecting the communities of Jefferson Hills, West Mifflin, Dravosburg, Duquesne and Clairton). The maps are identified as:

- ⇒ 53A: Clairton Boulevard (PA Route 51) to Camp Hollow Road, within the municipalities of Clairton, Jefferson Hills and West Mifflin
- ⇒ 53B: Camp Hollow Road to Homeville Road, within the municipalities of West Mifflin and Dravosburg
- ⇒ 53C: Homeville Road to Duquesne Boulevard (PA Route 837), within the municipalities of West Mifflin and Duquesne
